Letter Regarding Gender Ideologies

Beloved in Christ,

In this turbulent hour, I write to you with a heavy heart, yet filled with the resolve that we, as followers of Jesus Christ, are called to exhibit in times of trial. Like our forefathers we have been called to bear our cross. Our children, the very seeds of our faith and future, are being exposed to activities and ideologies that threaten their emotional, physical, and spiritual wellbeing and future.

We have increasingly been hearing from many, especially parents and grandparents, who have expressed deep concerns about Gender Ideology programs such as "Drag Queen Story Hour" and other such activities taking place within our broader educational system. It is also becoming clear that some children are being influenced while their parents are shut out of decisions that will have long-lasting, irreversible consequences. These are decisions that not only hurt our children in this life but jeopardize their eternity.

We hear your concerns. We share in your anguish. This is not merely an assault on our values; it is an assault on the very fabric of our families and our faith. It is an assault on our future.



The Apostle St. Paul, even when faced with great personal danger, appealed to Caesar to make his voice heard in defense of the Gospel (Acts 25:11). As clearly articulated by section 2a of our Canadian Charter of Rights and Freedoms, every person has equal fundamental freedoms to live according to their conscience and religion and that every person has the right to live in liberty and security of the person as set out in section 7 of the same Charter. These rights protect every person without favouring any particular group over the other and without infringing on the rights of any other group.
